### A WORD FROM THE REGISTRAR

Board members will meet next week for their annual strategy meeting. The strategy meeting is the Board's opportunity to consider the issues affecting engineers – including all the feedback you have provided through surveys, meetings and seminars with BPEQ staff and general contact – and set out a strategic plan for BPEQ for the next 12 months. Following the strategy meeting I will update you on the outcomes and any new initiatives.



RPEQs who have already renewed their registration for 2018/19 would know that a new process has been introduced this year where renewals are done online; except for RPEQs who have fitness to practice or continuing professional development issues. The move to online renewals has been largely successful with greater numbers of RPEQs already renewing their registration at this point in the renewal period compared to previous years. The minor problems with the new process have been noted and BPEQ will be inviting your feedback on the process in the coming weeks.

All registration renewals are due by 31 May 2018. If you need further information on how to renew your registration please see your renewal notice, the renewal guidelines and the FAQs included in the April e-news.

BPEQ staff have upcoming trips to Emerald, Capella,

Longreach, Winton and Barcaldine where they will meet with councils and engineering firms and present at the IPWEAQ CQ Branch conference on the PE Act and RPEQ system. Contact BPEQ's Communication and Media Adviser for more information on these trips.

Finally, Chemical, Environmental and Geotechnical engineers wanting to become a RPEQ have another option to be assessed for registration after Professionals Australia were approved by the Minister for Housing and Public Work to assess engineers in these disciplines.

# UPDATE ON UNAUTHORISED USE OF YOUR NAME, SIGNATURE AND RPEQ NUMBER

This issue has been previously discussed in e-news articles in May 2015 ('Electronic signatures – what you need to know'), February 2017 ('Unauthorised use of signatures on certification documents') and January 2018 ('Advice on unauthorised use of your name and RPEQ number').

BPEQ has seen several instances of RPEQ's names, electronic signatures and numbers being used without their authority. Sometimes this has been because of lax practices (e.g. an employee accessing and applying a RPEQ's electronic signature without express authority), but more concerningly there are cases where the improper use of a RPEQ's name, electronic signature and number has been intentionally fraudulent.

Such conduct can lead to prosecution by the Queensland Police Service (QPS) for forgery or fraud, or by BPEQ for the use of the RPEQ title by non-RPEQs.

Recently the QPS successfully prosecuted an employee of a construction company in the Magistrates Court. This was for the fraudulent use of the name, signature and RPEQ number of a former employee on Form 16 building aspect certificates for retaining walls. The offending employee was sentenced to a suspended term of imprisonment.

This case highlights the seriousness of the conduct. Deterring fraudulent conduct is important for the protection of the public who rely on RPEQ certification as an assurance of expertise in structural soundness.

Some of the tips for RPEQs in the previous e-news articles, for reducing risk in this area, have been:

- Take all steps that you can to prevent the unauthorised use of your electronic signature, especially when you leave a firm.
- Keep sufficient records of the engineering jobs that you perform so that you can later identify whether you did or did not provide a particular certification.
- Ensure that your contact details on the BPEQ register are current so that someone wishing to confirm that you actually signed a certificate can contact you promptly.

 If you become aware that your signature may be being used without your authorisation, take immediate action including obtaining legal advice, making a complaint to the QPS, and notifying BPEQ. Also consider notifying any person who may have relied on a forged document.

When BPEQ becomes aware of the unauthorised use of a RPEQ's signature, BPEQ notifies the QPS. BPEQ also recommends to the RPEQ that they make a formal complaint to the QPS. Although some matters can be prosecuted by BPEQ, it can only issue fines. Whereas fraud offences prosecuted by the police can lead to prison sentences if the person is convicted.

Incidentally, the maximum fines for offences under the Professional Engineers Act 2002 will rise from 1 July 2018 with an increase in the value of a 'penalty unit' from \$126.15 to \$130.55. This will make the maximum penalty \$130,550 for an offence under section 114 of the PE Act (non-RPEQ using RPEQ title).

# KIM HINES-NG: BACK IN THE WORKFORCE BURSARY RECIPIENT

RPEQ Kim Hines-Ng (07440 – Civil) attended a Safety in Design CPD course with the help of BPEQ's Back in the Workforce bursary.

Here Kim shares her experience at the course:

The Safety in Design course provided participants with an overview of the Work, Health and Safety requirements of designers and engineers. What I found particularly useful was the focus on understanding the underlying principles contained in the WHS legislation.

John Giles, the presenter, demonstrated a detailed understanding of the processes and principles across numerous engineering disciplines and as such, the material presented was relevant to all. Real world case studies where discussed and available review tools were worked through as a group.

The benefits of a holistic approach to managing engineering risk was recommended. The advantage of designers reviewing the overall lifespan of the project from design and construction through to operation and demolition was discussed and demonstrated. The course also provided definitions for terms commonly used in risk reduction methodologies and helped to dispel confusion between them.

Overall, I found the course was well presented, relevant across a number of industries and practical. The knowledge gained will be able to be implemented across all of our structural design projects. I believe it is important that all companies, regardless of their size, are able to comply with the duties and obligations of the WHS Legislation.

BPEQ's Back in the Workforce bursary is open to female RPEQs, non-practising professional engineers and former RPEQs based in Queensland.

The bursary supports successful applicants to attend CPD courses and maintain or regain their registered status.
